No. 9/46/2014-1GR1/85 E- District is one of the State Mission Mode Project under the National e-Governance Plan (NEGP). The project focuses on complete backend workflow computerization of various citizen centric services being delivered at District & sub-district level. For this purpose, horizontal connectivity is to be provided to the points of delivery and offices processing the citizen centric services. In this direction M/s Bharat Sanchar Nigam Limited (BSNL) has been asked to provide leased lines for connecting these field offices with Punjab wide Area Network (PAWAN). The State Government has agreed to provide free Right of Way (RoW) to BSNL without further need of permission under the State agencies and electric utilities in the State. The free Right of Way shall be without any cost implication or submission of bank guarantees by the bandwidth service provider i.e. BSNL.

Further, State government has also agreed to provide similar free Right of Way to any other bandwidth service provider, selected by Department of Governance reforms, under e-District or any other project for extending PAWAN connectivity to last mile field offices of the State Government, in future.


