No. 9/19/2014-1GR1/666131/1 In partial modification of Punjab Government Notification No. 9/19/2014-1GR1/358384 dated 3-12-2014, the Governor of Punjab is pleased to direct that there shall be no form fee in respect of all government service which are being provided to the citizens through State Portal or through front end delivery channels like SUWIDHA Centers. Regarding the user fee/facilitation charges and services covered under other applications/ projects, it is hereby clarified as under:

- a) The user fees/facilitation charges for each of the 59 service shall be applicable irrespective of the service being provided through any application software/project such as State Portal/eDistrict/Web Suwidha/SSDG.
- b) There shall be no form fee for the services being offered through the existing online/across the counter service delivery channels e.g. Suwidha Centers.
- c) The forms for these services will be made available on Punjab State Portal i.e. [www.punjab.gov.in](http://www.punjab.gov.in) for free downloading. The forms for these services shall not be sold at existing Suwidha Centers to the citizens. Printed forms shall also be made available at Suwidha Centers.
